D. AUDIENCE PARTICIPATION

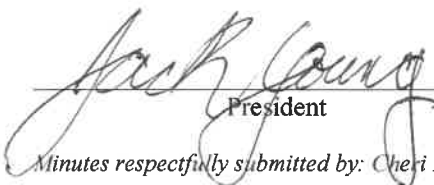
