## Web Accessibility Notice

### Brief Explanation about Section 504 and Title II

Section 504 protects qualified individuals with disabilities from discrimination in programs and activities that receive federal funding. Specifically, Section 504 prohibits school districts from excluding individuals with disabilities from the participation in, be denied the benefits of, or be subjected to discrimination under any District program or activity. Title II extends this prohibition on discrimination established by Section 504 to all activities of state and local governments regardless of whether these entities receive federal financial assistance.
