\_\_\_\_\_ I understand that the expectations for classwork and grading will follow district policy for On-site instruction. Courses taken by students participating in At-Home Learning will be included in calculating GPA and class rank in accordance with local policy.

\_\_\_\_\_ I understand that some elective courses may have coursework that can only reasonably be completed in person. Some courses may require a student to obtain equipment from campus in order to complete coursework virtually.
