In consideration of the Loving Municipal School District

Permitting _____ to participate in athletics sanctioned by the New Mexico Athletic Association, we hereby give permission and consent to participate in such activity, including participation in all out-of- town consent pertaining to such activity, and we further agree as follows:

1. Authorization for Medical Services

I/We request that I/We be contacted within a reasonable time in the event of illness or injury requiring medical service. In the event I/We cannot be reached I/We Parent(s)/ guardian(s) designate the Athletic Director, Team Coach, Athletic Trainer or his/her designee to act in my/our behalf to authorize such hospitalization, medical attention and surgery as may be required in an emergency because of illness or injuries sustained by my/our child/ward while participating in school athletics. In the event we recognize and relinquish our responsibility to a participating physician and/ or medical personnel acting in the best interest of my child/ward. I/We hereby assume financial responsibility for hospitalization, medical attention, and surgery provided.

2. Please check the Appropriate Insurance Declaration

_____ A. We have purchased the group activity insurance plan with the Loving Municipal School District recommends, and have paid all insurance premiums required for our child to have insurance coverage and protection.

_____ B. We are insured with _____ Policy # _____ and agree to maintain this coverage for the tenure of his/her participation in any school activity.

3. We hereby waive any claims or cause of action against the Loving Municipal School District which may arise by reason of injuries to our child because of such participation and agree that said school district is released and forever acquitted from all and any claims of liability to our child, or both for injuries sustained by our child because of such participation, excepting any claim for injury which may arise as the sole result of negligence on the part of the said school district. We further hereby agree to hold harmless and to indemnify said school district of and from any and all actions, causes of actions, claims liabilities, cost, and expenses, including attorney fees, on account of, or in any way growing out of injuries sustained by our child because of such participation, excepting those which may arise as the sole result of negligence on the part of the said school district.

- 4. Drinking and Controlled Substances (drugs/alcohol):** These are offenses that will not be tolerated. Athletes who are found in possession of or in partaking these substances will be suspended from athletics for a period of 45 school days. (This includes 24 hours per day, seven days per week) For a second offense the student/athlete will be suspended 180 school days (plus practices and activities associated with athletics in a school year). A third offense will result in a ban from all athletic activities for the remainder of their school career at the Loving Municipal School District.
- 5. Drug Testing:** All athletes are subject to random drug testing in the Loving Municipal School District. Random Steroid Testing will also be implemented on student/athletes throughout the year. Failure to pass or a positive result in these tests will carry the same suspension as Drinking and Controlled Substance Abuse.
- 6. Eligibility:** An athlete must meet the following scholastic requirements to be eligible for athletics. The New Mexico Athletic Association and/or the Loving Municipal School Board of Education established these requirements.
- An athlete must have at least a 2.0 grade point average in grades 6 through 12 for the previous grading period or semester.
 - An athlete must not have any “F’s” in a previous grading period (9 weeks or end of semester).
