Dear Superior Families,

Beginning on Monday, March 23rd, the Superior Unified School District will be serving a combined breakfast and lunch to all children ages 18-under in the Superior Unified School District boundaries. Families must call the high school office (520)689-3000 ext. 3101 by 10:00AM to request a meal(s). Meal(s) can either be picked-up through a drive-through service behind the high school kitchen (11:00AM) or delivered to a designated bus stop. Meal(s) will begin to be delivered by 10:50AM each day. Families can request to be served on multiple days. If you are picking-up a meal(s) please enter through the main entrance of the District parking lot and then proceed west along the front of the high school through the bay gates. Cars will stop behind the kitchen, receive their meal(s), and exit out the opposite bay gates by the tennis courts. Students must be present at all times in order to receive a meal. This is a Department of Education requirement.

In the event that school does not reopen by March 30th, the Superior Unified School District will be prepared to provide alternative forms of instruction to its students. This will include independent study options for JFK Elementary and both online and independent study options for students at Superior Jr/Sr High School. Both JFK Elementary and SJSHS teachers will be calling students in their respective classes next week in order to identify the best possible means to send and receive instructional packets. SJSHS students who are currently enrolled in online PLP classes will be able to login to continue working in order to complete their spring classes.

The District office and both school site offices will remain open beginning next week. Please be patient as we all try to navigate through these difficult times. Spring sports and practices have been cancelled until further notice. We have not received any new information as to when school may reopen. We will keep you informed as best as we can. Feel free to contact the District office or each school site if you have any questions.
