

Tombstone Unified School District #1 School Tax Credit Donation



Your contribution costs you nothing & will immediately go to support the school & program of YOUR choice.

The amended Arizona tax law (ARS 43-1089.01) allows taxpayers a TAX CREDIT on their state taxes. *Beginning with the 2006 tax year, the TAX CREDIT maximum contributions are:*

- ✓ **\$400 for married couples filing joint returns**
- ✓ **\$200 for single individuals and head of household**
- ✓ **\$200 for married couples filing separate returns**

- It is NOT a requirement for the taxpayer to have a child enrolled in a public school to donate.
- 100% of your donation comes back to you on your state income tax return.
- Taxpayers may chose to contribute tax monies to the school or program of their choice instead of paying it to the state general fund.
- Tax credit donations must be received or postmarked by December 31 of the taxable year for which the credit is claimed. A receipt will be mailed to you for use in preparing your state tax return.
