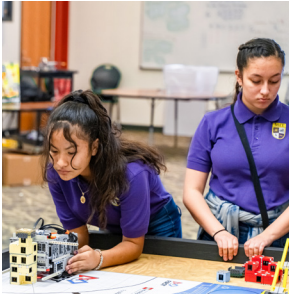
## 2020 Arizona School Tax Credit

*“Support our school and get a dollar-for-dollar tax credit.”*

The Arizona State Public School Tax Credit Law (A.R.S. §43-1089.01) gives students the credit they deserve. Your donation helps support extracurricular activities and programs. By making a contribution you will receive a dollar for dollar tax credit on your state tax return in **any amount** up to \$400 for married couples filing jointly, \$200 for each spouse for married couples filing separately or \$200 for single taxpayers.

**Donations for the 2020 Tax year may be given until the deadline of April 15th, 2021.**

For the purpose of claiming Arizona's tax credit for contributions made or certain fees paid to a public school, the Arizona Department of Revenue now requires taxpayers report the school's County Code, Type Code, and District Code & Site Number (CTDS) number on Form 322, which is included with the Arizona income tax return. The CTDS is a nine (9) digit number that the Arizona Department of Education uses to identify Arizona public and charter schools. CTDS EEF: 07-823-9001 MIT CTDS: 07-823-9001

Return this form to the school with your nonrefundable check made payable to "Maricopa Institute of Technology" by April 15, 2021. If you prefer to mail your check to the school, the envelope must be postmarked on or before April 15, 2021. Mail to Maricopa Institute of Technology
