Summative Assessment/Summative Conference Evaluator reviews all observation data and the compilation of documentation collected throughout the year Evaluator completes Summative Assessment form in the TLE Platform Data from student surveys must be referenced in the commentary section on standards 3,4,7, and 8 on Summative Assessment form (if data is inconsistent from what the Evaluator has seen, the commentary must justify the difference) Evaluator rates all 10 standards (comments) Evaluator saves changes in the TLE Platform and shares with the teacher Summative Conference Done individually Survey commentary must be included as notes in the Conference form Notes taken and loaded into platform	Deadline: May 6th
