

## COVID Testing Sites

We know that many people in our school community may need access in the coming weeks to COVID testing. In an effort to help people find testing sites we have compiled the list of locations below. Please remember if you have symptoms of COVID-19, the most sensitive and accurate test is the molecular or PCR test. All employees and students should request a **molecular/PCR** test when being tested. All of these locations have the molecular/PCR test available, but **please specify that this is the test you need.**

- **College of the Canyons** - 26455 Rockwell Canyon Rd., Parking lot 7
  - Appointment Required
  - Drive up only
  - Will test minors
  - Insurance information requested, but free if you do not have insurance

  - Molecular/PCR test
  
- **Hansen Dam Recreational Center**- 11798 Foothill Blvd., Lake View Terrace
  - Appointment Required
  - Drive up only
  - Will test minors
  - Insurance information requested, but free if you do not have insurance

  - Molecular/PCR test
  
- **Providence Urgent Care** - 24035 Newhall Ranch Rd., Valencia (661) 291-3444
  - No Appointment required
  - Will test minors
  - Takes PPO and HMO. Without insurance it is \$150 to see a Doctor and \$100 for the test.
  
- **Facey Medical Group** - 26357 McBean Pkwy (661) 222-2643
  - No Appointment required
  - Will test minors
  - Will take PPO insurance, otherwise visit is \$100
  
- **Exer Urgent Care** - 25548 The Old Rd., Stevenson Ranch (661) 556-9020
  - No Appointment required
  - Will test minors
  - Drive-up
  - Takes PPO and HMO. Without insurance it is \$170 for the visit and \$70 for test.

  - Will test minors > 3 years of age
  - Drive-up

If you have health insurance, your health plan is required to pay for approved COVID-19 tests, according to the State of California. By providing your insurance information, this allows us to bill your insurance for the cost of the test. Insurance companies cannot bill individuals or charge any co-payments for COVID-19 tests.
