B. THE FOLLOWING ITEMS ARE ISSUED AS CLARIFICATIONS TO THE BID DOCUMENTS:

1. Attached is the Sign In / Out sheet from the mandatory bid walk on February 12, 2020
2. All lunch shelters are to be painted
3. Exterior doors are to be painted on four sides: The exterior door side, the top, the left and right sides
4. The door frames are to be painted to the inside jamb on all three sides: right, left and top
5. Portable ramps skirting, handrails are to be painted
6. There is new wrought iron fencing being installed in the parking lot and in front of classrooms – these are to be painted.
7. Galvanized parapet enclosures are not to be painted. They are to be pressure washed

8. All downspouts are to be painted with the exception of galvanized metal
9. Galvanized and aluminum metal does not get painted
10. Murals and tiles are not to be painted
11. Paint all exterior door swing lines on the ground by each exterior door, the existing color
12. All cover walkways are to be painted: posts, underside, edges
13. All conduits are to be painted the color of the adjacent wall, walkway that they are attached

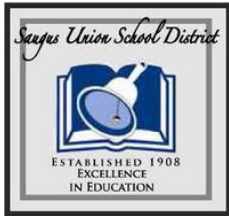


