Applicant further says that in applying for admission to the Lawrenceburg Community Schools on behalf of said minor child(ren), I/we have
provided to said school district accurate and truthful information, and further say that I/we have not knowingly withheld, concealed, or
misrepresented any information that would have a material bearing upon the eligibility of said minor child(ren) to attend Lawrenceburg
Community Schools.

Further, I/we acknowledge that we have been advised that giving false information of residency to a school official may result in prosecution
for the offense of falsification. If evidence and investigation indicates that the student's custodial parent/guardian does not reside in the
Lawrenceburg Community School District or that transfer tuition status has not been approved, at least three of the following proofs of
residence will be required:

1. Most recent income tax returns
2. Deed or written lease
3. Mail in the guardian's or legal resident's names at stated residency
4. Insurance policies indicating place of residence
5. Driver's license
6. Telephone listings
7. Certification of registration from the Board of Elections
8. Utility bills
9. Rental agreement
10. Other

Finally, I/we acknowledge that if any further investigation reveals that I/we do not reside in the Lawrenceburg Community School attendance
district or have approved transfer tuition status, my/our child(ren) shall be withdrawn from the school system and I/we could be obligated to
pay any monetary reimbursement for educational services due the district.
