- 1. Sheriff's Office/Jail: presentation of a Lifesaving Award to Officer Ashton Powers and an Achievement Award to Officer Claire Hayes.
- 2. Dan Bevier and Jason Baran, Salt River Project: Update on the status of agreements between the Environmental Protection Agency and Coronado Generating Station.
- 3. Finance Department: Discussion and possible adoption of the property tax levy for 2016-2017.

#### County Manager/Clerk of the Board:

- \*A. Request approval of demands as distributed to the Apache County Board of Supervisors between August 1, 2016 to August 15, 2016. Demands are payments made or to be made, by the County. Specific details of the demands may be requested through the County public record request process.

Human Resources: Request approval to convert the currently vacant 30 hour per week Administrative Assistant I (range 22) to a 40 hour per week Administrative Assistant II (range 26) position a fill the vacancy. The increase will result in a cost increase of seven thousand, seven hundred twenty four dollars and seventy five cents (\$7,724.75).

#### **Engineering Department:**

- \*E. Request approval to solicit bids for the installation of a new water well and appurtenances to be installed on the County property in Vernon, near the Blue Hills Transfer Site.
- 5. Engineering Department: Update on the state of emergency declaration due to flooding and residual mud throughout Apache County.
- 6. Engineering Department: Discussion and possible approval of a resolution reducing the speed limit on County Road 2060 and 2041 from 25 miles per hour to 15 miles per hour.
- 7. Emergency Management: Discussion and possible approval to accept the Emergency Management Performance Grant (EMPG), #DHS-16-GPD-042-09-01in the amount of One hundred eighty four thousand, five hundred thirty one dollars and ninety one cents. (\$184,531.91). This grant requires an in-kind and cash match of 50%.
- 8. Sheriff's Office: Discussion and possible approval to enter into a one (1) year lease agreement with Sanders School District #18 ending June 30, 2017 for the use of the Apache County Sheriff's Office Sub-station at a cost of \$325.00 per month.

## OFFICIAL PROCEEDINGS OF THE APACHE COUNTY BOARD OF SUPERVISORS MEETING

August 1, 2016 St. Johns, Arizona

Present were: Chairman Joe Shirley, Jr., Vice Chairman Tom M. White, Jr. and Supervisor Barry Weller. Also present, County Manager/Clerk of the Board, Delwin Wengert and County Attorney Michael Whiting.

Chairman Shirley called to order the Board of Supervisors meeting at 8:33 a.m. in the Board of Supervisors chambers, County Annex Building, 75 West Cleveland Street, St. Johns, Arizona, and welcomed all in attendance.

Glenn Joy led the Pledge of Allegiance.

Ferrin Crosby gave the invocation.

Chairman Shirley called for the Library District items.

Judith Pepple, Library Director, requested approval to create, advertise and fill a new Library Specialist I - Floater position. This position would work full-time 32 hours per week, and be scheduled throughout the district based on public and technical services demands. **Mr. White moved approval, seconded by Mr. Weller.** Vote was unanimous.

Judith Pepple., Library Director, requested approval of a lease agreement between the Sanders Unified School District #18 and the Apache County Library District effective July 1, 2016 through June 30, 2017 in the amount of three hundred twenty five dollars (\$325.00) per month. Mr. Weller moved approval, seconded by Mr. White. Vote was unanimous.

Judith Pepple, Library Director, presented notification of the retirement of Judith Pepple, Library Director and County Librarian, effective September 16, 2016 and request approval to payout her accumulated sick leave balance per Apache County Human Resources Policy 3.25. Mr. Weller moved approval, to payout Ms. Pepple's sick leave balance, seconded by Mr. White. Per Mr. Weller's request, Ms. Pepple provided an overview of what the Library District had accomplished over the past 20 years. Vote was unanimous.

The Board of Supervisors recognized Ms. Pepple for her dedicated years of service.

Mr. White moved to adjourn the library District meeting, seconded by Mr. Weller. Vote was unanimous.

Craig Sullivan, CSA Executive Director, provided a report on recent County Supervisors Association activities including a discussion on the recent legislative session and budget. No action was needed or taken.

The Board of Supervisors sat to hear the public hearing, discussion and possible adoption of the

2016-2017 Final Budget for Apache County and opened the floor for public comment. Mr. Wengert stated the only change to the final budget from the tentative budget was rate is down in the Fire District Assistance Tax. Mr. Wengert stated the total property taxes went down about \$89,000. Mr. Wengert stated there are no recommended increases for the employees this year due to the financial situation and he appreciated the department heads and elected officials who worked to get the budget together and appreciate their understanding that there was no additional funding to increase their budgets this year. Mr. Weller moved to close the public hearing portion of the item, seconded by Mr. White. Vote was unanimous. Mr. White moved to approve the final budget for 2016-2017, seconded by Mr. Shirley. Mr. Weller stated he is in complete disagreement with the general consensus of county officials of the assumption we have to raise taxes to cover the costs of essential services. Mr. Weller stated he sees several areas of non-essential services and need to refocus attention on essential services in a much greater way for the citizens without raising taxes, so he will be opposing approval of tax increases and the continued inappropriate spending that takes place in this county. Motion passed 2-1 with Mr. Weller voting nay.

#### APACHE COUNTY RESOLUTION FOR THE ADOPTION OF THE BUDGET FISCAL YEAR 2017 RESOLUTION NO 2016-09

WHEREAS, in accordance with the provisions of Title 42 Chapter 17, Articles 1-5, Arizona Revised Statutes (A.R.S.), the Board of Supervisors did, on July 7, 2016, make an estimate of the different amounts required to meet the public expenditures/expenses for the ensuing year, also an estimate of revenues from sources other than direct taxation, and the amount to be raised by taxation upon real and personal property of Apache County, and

WHEREAS, in accordance with said sections of said title, and following due public notice, the Board met on July 7, 2016, at which meeting any taxpayer was privileged to appear and be heard in favor of or against any of the proposed expenditures/expenses or tax levies, and

WHEREAS, it appears that publication has been duly made as required by law, of said estimates together with a notice that the Board would meet on August 1, 2016, at the office of the Board for the purpose of hearing taxpayers and making tax levies as set forth in said estimates, and

WHEREAS, it appears that the sums to be raised by taxation, as specified therein, do not in the aggregate amount exceed that amount as computed in A.R.S. §42-17051(A),

**THEREFORE BE IT RESOLVED,** that said estimates of revenues and expenditures/expenses shown on the accompanying schedules as now increased, reduced or changed by and the same are hereby adopted as the budget of Apache County for the fiscal year 2016-2017.

The Board of Supervisors sat as the Board of Directors to hear the 2016-2017 Final Budgets for the Apache County Library District, Apache County Public Health Services District, Apache County Flood Control District, Apache County Juvenile Jail District, Apache County Jail District, Junior College Tuition and the Post-Secondary Education. Chairman Shirley opened the floor for a public hearing There were no members of the public who wanted to comment. Mr. Wengert stated because of a drop in the assessed valuation, the funds generated by the jail district dropped about \$73,000 even though we are at the maximum levy limit of .20 cents, that negatively affects the jail distinct so that affects their budget. Mr. Wengert stated there are several other districts affected. Mr. Weller moved to close the public hearing portion on the final budget for the districts, seconded by Mr. White. Vote was unanimous. Mr. White moved to approve district budgets, seconded by Mr. Shirley. Mr. Weller stated he opposes approval of the budget for several reasons; specifically the juvenile jail district which is supposedly to reduce costs to the citizens, yet continues to spend exorbitantly in non-essential areas, and the abuse of the flexibility language which he does not think is needed. Ryan Patterson, Finance Director, thanked everyone for their efforts in working through the budget process and those elected officials and department heads that worked with him and sacrificed to keep their budgets where they were last year by not giving increases to employees who do deserve raises. Motion passed 2-1with Mr. Weller voting nay.

Mr. Wengert requested approval of the Consent Agenda items. A & B. Mr. White moved approval, seconded by Mr. Shirley, Mr. Weller stated he will be voting against the Consent Agenda items because of the demand issue he has brought forth before. David Romeo, Chief Deputy Treasurer, requested approval of a renewal on a line of revolving credit for Apache County in an amount of five million, six hundred thousand dollars (\$5,600,000) and the amount will be allotted to the County entities when needed and when a fund within the chart of funds is drawn into the red and is required to be brought back in the black by a draw on the line of credit. **Mr. Weller moved approval, seconded by Mr. White.** Mr. Weller and Mr. Romero held a discussion regarding who is responsible for the line of credit. Mr. Romeo stated there is no fee associated with the line of credit for the County. Mr. Romeo stated there were no policies established in the Treasurer's office so they are in the process of creating specific policies related to what the statutes allow when lending. Vote was unanimous.

Angela Romeo, Election Director, requested possible approval of the designated polling places for the upcoming August 30, 2016 Primary Election. **Mr. White moved approval, seconded by Mr. Weller.** Vote was unanimous.

Angela Romero Election Director, requested approval of all Tally Board, Poll Workers and Election Day Technicians for the upcoming August 30, 2016 Primary Election. Mr. Weller moved approval, seconded by Mr. White. Mr. Weller and Ms. Romeo held a discussion regarding how tally board workers are obtained. Mr. Weller suggested in the future, look at the fact that on the tally board, every worker is from St. Johns and he requested that be looked at as a balance issue. Mr. White asked Mrs. Romeo if she would again be utilizing the Ganado Road Yard as a holding location for equipment. Mrs. Romeo stated yes; both the Ganado and the Chinle Road Yards will be holding sites for collection of the election equipment and the to park the U-Hauls used during the election that transport equipment. Vote was unanimous.

Barry Aarons, The Aarons Company, provided an update on proposed legislative issues. No action was needed or taken.

Chairman Shirley opened the floor for call to the public.

Walter Wiltbank, addressed the board during call to the public and stated years ago there were five ranchers that leased land within in Apache County and the Board of Supervisors did nothing with the transfer of the Bureau of Land Management (BLM) leases from the BLM to the County so for the past 32 years, the ranchers have been freeloading at no fault of their own, because the County didn't bother to bill them or do anything about it. Mr. Wiltbank stated now the County is in the process of wanting to collect fees on the grazing leases and he wants to know how the County is going to handle the process. Mr. Wiltbank stated if the lease goes to anyone but himself, approximately seven miles of fencing would have to be built and that would be at a cost to either the County or the new lessee. Mr. Wiltbank stated since the County is at least half responsible for him not paying a lease over the past 32 years, he proposed if he was awarded the lease, he would pay half of the lease that he would have paid the BLM had it stayed with them, and would like a 10 year lease from 2016 to 2026. Mr. Weller asked Mr. Wiltbank

how much 50% of the grazing fee would be. Mr. Wiltbank responded there is about two sections and would be about \$250.00 multiplied by the 32 years.

Ester Wiltbank addressed the Board during call to the public and provided an overview of how the property was established at the prison south of St. Johns. Mrs. Wiltbank stated her family worked with County Manager Clarence Bigelow and Supervisor Art Lee and they told her family this was a win/win, and the water runoff from the prison would run into a retaining pond and could be used for livestock which didn't happen; they finally put a little spigot to use. Mrs. Wiltbank stated they were told since they gutted their permit for the prison, they could use the remainder of the land within the permit for the rest of their life at no cost because they removed the big meadow from the lease for the septic system for the prison. Mrs. Wiltbank stated she has a letter from the County stating they were going to take the land but she failed in getting an agreement in writing they could use the land for the remainder of their life for free, but the County did stop charging them for remainder of the property they used. Mrs. Wiltbank stated she had heard the County is going to open the leases up for bid to someone who wants to come in and buy up the leases and the leases have been in her family for 4 generations and why the County would even entertain someone coming in because they have a deep pocket to outbid people who have been here seems contrary to what Apache County stands for. Mrs. Wiltbank requested the County keep their word and start charging them at the same level. Mrs. Wiltbank stated the County is opening up a big problem of the environmentalists who want to come in and buy up the leases and take them off the county roll and not put cattle there, and that would be an injustice.

Jackie Yazzie, Jr. a resident of the Lupton addressed the Board and asked what is being done on the roads up north; school is starting and asked why Mr. Weller, District III Supervisor isn't helping in his community. Mr. Yazzie stated there were four incidents during construction on Interstate 40 and there used to be county deputies help control the traffic but he hasn't seen deputies in his area in a while. Mr. Yazzie asked the Board members to work with Mr. Weller to help get some things done within his chapter area.

Chairman Shirley asked Mr. Wengert to look into the issues raised by the members of the public.

Mr. White moved to adjourn the meeting, seconded by Mr. Weller. Vote was unanimous.

## SUBRECIPIENT AGREEMENT BETWEEN

## **Apache County Emergency Management**

#### AND

## The Arizona Department of Emergency and Military Affairs FOR

Emergency Management Performance Grant - EMF-2016-EP-00009-S01 WHEREAS, A.R.S. § 41-4254 (6) charges the Arizona Department of Emergency and Military

Affairs (DEMA) with the responsibility of administering funds.

THEREFORE, it is agreed that DEMA shall provide funding to Apache County Emergency Management ("Subrecipient") under CFDA # 97.042 for services under the terms of this Grant Agreement.

## I. PURPOSE OF AGREEMENT

The purpose of this Agreement is to specify the rights and responsibilities of DEMA in administering the distribution of Emergency Management Performance Grant (EMPG) funds to Subrecipient, and to specify the rights and responsibilities of Subrecipient as the recipient of these funds.

## II. TERM OF AGREEMENT, TERMINATION AND AMENDMENTS

This Agreement shall become effective on July 1, 2016 and shall terminate on June 30, 2017. The obligations of Subrecipient as described herein will survive termination of this agreement.

## III. DESCRIPTION OF SERVICES, SUPPLIES AND EQUIPMENT

Subrecipient shall provide the services for DEMA, and shall purchase the supplies and equipment for Subrecipient's use in conjunction with this Agreement as set forth in writing Subrecipient's grant application titled "EMPG FY16", a copy of which is attached as Exhibit III

- a) The FY 2016 EMPG covers eligible costs from July 1, 2016 June 30, 2017. The funds awarded in the grant agreement shall only be used to cover allowable costs that are incurred during the agreement period. Grant agreement funds shall not be used for other purposes. Allowable costs are defined in the FY 2016 EMPG Notice of Funding Opportunity (NOFO), a copy of which is attached as Exhibit III(a).
- b) All EMPG funded personnel must complete training requirements for the National Incident Management System (NIMS) as stated in the EMPG NOFO, and Subrecipient must provide DEMA with written proof of completion for each individual as soon as that individual's training is completed. All EMPG funded personnel must also participate in no less than three exercises run by either Subrecipient or DEMA in a 12 month period.
- c) Finance & Administration- DEMA will serve as the primary fiscal agent for all FFY 2016 EMPG funds.

- i) The FY 2016 EMPG program has a 50% cost match (cash or in-kind) requirement, as authorized by the *Robert T. Stafford Disaster Relief and Emergency Assistance Act*, as amended, (Pub. L. No. 93-288) (42 U.S.C. §§ 5121 et seq.), specifically, *Title VI*, sections 611(U) and 613. Federal funds cannot exceed 50% of eligible costs. Unless otherwise authorized by law, federal funds cannot be matched with other federal funds. All funds received by Subrecipient through DEMA under this Agreement are agreed to be federal matching funds; Subrecipient shall be solely responsible for providing the other 50% (cash or in-kind) in order to obtain these federal matching funds.
- ii) The Federal Emergency Management Agency (FEMA) administers cost matching requirements in accordance with 2 CFR § 200.306. To meet matching requirements, Subrecipient contributions must be reasonable, allowable, allocable, and necessary under the grant program and must comply with all federal requirements and regulations.

## IV. MANNER OF FINANCING

DEMA shall:

- a) Provide up to \$184,531.91 to the Subrecipient for 50% of the costs associated with the services, supplies and equipment identified in Exhibit III. Subrecipient will provide the services required by part III of this Agreement and acquire the supplies and equipment identified therein for its own use, unless a change is agreed to as provided in part XII of this Agreement.
- b) Payment made by DEMA to Subrecipient shall be on a reimbursement basis only and is conditioned upon receipt of proof of payment and applicable, accurate and complete reimbursement documents, as deemed necessary by DEMA, to be submitted by Subrecipient. A listing of acceptable documentation is attached as Exhibit IV(b). Payments by DEMA to Subrecipient will be contingent upon DEMA receiving complete documentation for each expenditure from Subrecipient.

Payment maybe contingent upon certification of the Subrecipient's financial management system in accordance with acceptable standards in OMB Circular A-110.

## V. FISCAL RESPONSBILITY

It is understood and agreed that all of the funds provided by DEMA to Subrecipient under this Agreement shall be used by Subrecipient only for items and services to be acquired by Subrecipient under this Agreement. For any funds received under this Agreement for which expenditure is disallowed by an audit exemption or otherwise by DEMA, the State, or Federal government, Subrecipient shall reimburse said funds directly to DEMA immediately.

## VI. FINANCIAL AUDIT/PROGRAMATIC MONITORING

Subrecipient agrees to terms specified in A.R.S. § 35-214 and § 35-215.

- a) If Subrecipient expends \$750,000 or more from all federal funding sources during the fiscal year, Subrecipient shall submit an organization-wide financial and compliance audit report per Subpart F of 2 C.F.R. Part 200. Failure to comply with any requirements imposed as a result of an audit will suspend the release of federal funds by DEMA to Subrecipient until Subrecipient is in compliance with all such requirements.
- b) Subrecipient will be monitored periodically by DEMA, both programmatically and financially, to ensure that the project goals, objectives, performance requirements, timelines, milestone completion, budgets, and other related program criteria are being met. Monitoring will be accomplished through a combination of office-based reviews and onsite monitoring visits. Monitoring can involve aspects of the work involved under this Agreement including but not limited to the review and analysis of financial, programmatic, equipment, performance and administrative issues relative to each program, and may identify areas where technical assistance and other support may be needed. Subrecipient shall participate in and cooperate with all such monitoring by DEMA, and shall provide access to all personnel, documents, and other records as may be requested from time to time by DEMA. Subrecipient also shall comply with all requests of DEMA that DEMA deems necessary to assure the parties' compliance with their obligations under this Agreement.

## VII. APPLICABLE FEDERAL REGULATIONS

Subrecipient must comply with the EMPG FY 2016 NOFO, Office of Management and Budget (OMB) Circular's Code of Federal Regulations (CFR), and other Federal guidance including but not limited to:

- f) 28 CFR applicable to grants and cooperative agreements, including Part II, Applicability of Office of Management and Budget Circulators; Part 18, Administrative Review Procedure; Part 20, Criminal Justice Information Systems; Part 22, Confidentiality of Identifiable Research and Statistical Information; Part 23, Criminal Intelligence System Operating Policies; Part 42, Non-discrimination Equal

Employment Opportunities Policies and Procedures; Pairt 61, Procedures for Implementing the National Environmental Policy Act; Part 63, Floodplain Management and Wetland Protection Procedures; and Part 66, Uniform Administrative Requirements for Grants and Co-operative Agreements to State and Local Government.

g) OMB Circular A-133, Audits of States, Local Governments, and Non-Profit Organizations, at <a href="http://www.whitehouse.gov/omb/circulars/a133">http://www.whitehouse.gov/omb/circulars/a133</a> compliance supplement 201 2.

Included within the above mentioned guidance documents are provisions for the following:

## National Incident Management System (NIMS)

Subrecipient agrees to remain in compliance with National Incident Management System (NIMS) Implementation initiatives as outlined in the NOFO.

## **Environmental Planning and Historic Preservation**

Subrecipient shall comply with all applicable Federal, State, and Local environmental and historic preservation (EHP) requirements and shall provide any information requested by FEMA to ensure compliance with applicable laws including: National Environmental Policy Act, National Historic Preservation Act, Endangered Species Act, and Executive Orders on Floodplains (11988), Wetlands (11990) and Environmental Justice (12898) Subrecipient shall not undertake any project having the potential to impact EHP resources without the prior approval of DEMA/FEMA, including but not limited to communications towers, physical security enhancements, new construction, and modifications to buildings that are 50 years old or greater. Subrecipient must comply with all conditions placed on the project as the result of the EHP review. Any change to the approved project scope of work will require re-evaluation for compliance with these EHP requirements. If ground disturbing activities occur during project implementation, Subrecipient must ensure monitoring of ground disturbance and if any potential archeological resources are discovered, Subrecipient will immediately cease construction in that area and notify FEMA and the appropriate State Historic Preservation Office. Procurement and construction activities shall not be initiated prior to the full environmental and historic preservation review.

#### Consultants/Trainers/Training Providers

Billings for consultants/trainers/training providers must include at a minimum: a description of services; dates of services; number of hours for services performed; rate charged for services; and, the total cost of services performed. Consultant/trainer/training provider costs must be within the prevailing rates; must be obtained under consistent treatment with the procurement policies of Subrecipient and 2 CFR § 200.231,200.326 & 200.323.

#### Contractors/Subcontractors

Subrecipient may enter into written subcontract(s) for performance of certain of its functions under this Agreement in accordance with terms established in the OMB Circulars, Code of Federal Regulations, DHS Guidance/NOFO and DHS Program

Guidance. Subrecipient agrees and understands that no subcontract that Subrecipient enters into with respect to performance under this Agreement shall in any way relieve Subrecipient of any responsibilities for performance of its duties. Subrecipient shall give DEMA immediate notice in writing by certified mail of any action or suit filed and prompt notice of any claim made against Subrecipient by any subcontractor or vendor which in the opinion of Subrecipient may result in litigation related in any way to the Agreement with DEMA.

## **Personnel and Travel Costs**

All grant funds expended for personnel, travel, lodging, and per diem must be consistent with the Subrecipient's policies and procedures and the State of Arizona Accounting Manual (SAAM); must be applied uniformly to both federally financed and other activities of the agency; and will be reimbursed at the most restrictive allowability and rate. At no time will Subrecipient's reimbursement(s) exceed the State rate established by the Arizona Department of Administration, General Accounting Office Travel Policies: https://gao.az.gov/publications/saam

#### **Procurement**

Subrecipient shall comply with all of its own procurement rules/policies, all Federal procurement rules/policies (including but not limited to those outlined in this section VII of this Agreement), and all Arizona State procurement code provisions and rules. The Federal intent is that all Funds are awarded competitively. Subrecipient shall not enter into a Noncompetitive (Sole or Single Source) procurement agreement, unless prior written approval is granted by DEMA.

## Training and Exercise

Subrecipient agrees that any grant funds used for training and exercise must be in compliance with the NOFO. All training must be approved through DEMA/Arizona Department of Homeland Security training request process prior to execution of training contract(s). All exercises must utilize the FEMA Homeland Security Exercise and Evaluation Program (HSEEP) Toolkit for exercise design, development and scheduling. Subrecipient agrees to:

- a) Submit the HSEEP Toolkit Exercise Summary to DEMA with all Exercise Reimbursement Requests within 90 days of completion of the exercise in question.
- b) Post all exercises, documentation and After Action Reports/Improvement Plans via the HSEEP Toolkit within 90 days of completion of the exercise in question
- c) Within 60 days of completion of an exercise, or as prescribed by the most recent HSEEP guidance, the Subrecipient is required to upload the AAR/IP into the HSEEP Toolkit and email the AAR/IP to the local County Emergency Manager, the FEMA Region IX Exercise POC, HSEEP@dhs.gov, and the DEMA Exercise Officer.

## **Nonsupplanting Agreement**

Subrecipient shall not use funds to supplant State or Local funds or other resources that would otherwise have been made available for this program/project. Further, if a position created by a grant is filled from within, the vacancy created by this action must be filled within thirty (30) days. If the vacancy is not filled within thirty (30) days, Subrecipient

must stop charging the grant for the new position. Upon filling the vacancy, Subrecipient may resume charging for the grant position.

## E-Verify

Compliance requirements for A.R.S. § 41-4401—immigration laws and E-Verify requirement.

- a) Subrecipient warrants its compliance with all Federal immigration laws and regulations relating to its employees and to employees of any contractor or subcontractor retained through Subrecipient to provide goods or services related to this Agreement, including but not limited to A.R.S. § 23-214, Subsection A (That subsection reads: "After December 31, 2007, every employer, after hiring an employee, shall verify the employment eligibility of the employee through the E-Verify program").
- b) A breach of a warranty by Subrecipient regarding compliance with immigration laws and regulations shall be deemed a material breach of this Agreement and Subrecipient may be subject to penalties to be determined at DEMA's discretion, up to and including termination of this Agreement.
- c) DEMA retains the legal right to inspect the papers of any Subrecipient employee who works on the Agreement, and those of any employee of any contractor or subcontractor retained through Subrecipient to provide goods or services related to this Agreement, to ensure that Subrecipient is complying with the warranty under paragraph (a) above.

## **Property Control**

Effective control and accountability must be maintained by Subrecipient for all equipment and supplies acquired by Subrecipient under this Agreement. Subrecipient must adequately safeguard all such property and must assure that it is used for authorized purposes as described in the NOFO, grant application, and Code of Federal Regulations (CFRs). Subrecipient shall exercise caution in the use, maintenance, protection and preservation of such property.

- a) Equipment acquired by Subrecipient under this Agreement shall be used by Subrecipient in the program or project for which it was acquired as long as needed, whether or not the program or project continues to be supported by federal grant funds. Theft, destruction, or loss of property shall be reported to DEMA immediately.
- b) Nonexpendable Property is property which has a continuing use, is not consumed in use, is of a durable nature with an expected service life of one or more years, has an acquisition cost of \$300 (Three Hundred Dollars) or more, and does not become a fixture or lose its identity as a component of other equipment or plant.
- c) A Capital Asset is any personal or real property, or fixture that has an acquisition cost of \$5,000 (Five Thousand Dollars) or more per unit and a useful life of more than one year. If the Capital Asset current value is equal to or greater than \$5,000 at the end of life or required project activities is discontinued, Subrecipient must request and receive authorization from DEMA prior to disposition.

- d) A Property Control Form (if applicable) shall be maintained for the entire scope of the program or project for which property was acquired through the end of its useful life and/or disposition. All Nonexpendable Property and Capital Assets must be included on the Property Control Form. Subrecipient shall provide DEMA a copy of the Property Control Form with the final reimbursement request form, or no more than forty-five (45) calendar days after the end of the Agreement. The Property Control Form shall be updated and a copy provided to DEMA no more than forty-five (45) calendar days after equipment disposition, if applicable.
- e) Upon submission of the final quarterly programmatic report Subrecipient must file with DEMA a copy of the Property Control Form. Subrecipient agrees to be subject to equipment monitoring and auditing by state or federal authorized representatives to verify information.
- f) A physical inventory of the Nonexpendable Property and Capital Assets must be taken and the results reconciled with the Property Control Form at least once every two years. (1) A control system must be developed to ensure adequate safeguards to prevent loss, damage, or theft of the property. Any loss, damage, or theft shall be investigated. (2) Adequate maintenance procedures must be developed to keep the property in good condition.

## VIII. <u>DEBARMENT CERTIFICATION</u>

Subrecipient agrees to comply with the Federal Debarment and Suspension regulations as outlined in the "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion – Lower Tier Covered Transactions" Attached as Exhibit VIII.

## IX. FUNDS MANAGEMENT

Subrecipient must maintain funds received under this Agreement in separate ledger accounts and cannot mix these funds with funds from other sources. Subrecipient must manage funds according to applicable Federal regulations for administrative requirements, costs principles, and audits. Subrecipient must maintain adequate business systems to comply with Federal requirements. The business systems that must be maintained are:

- · Financial Management
- Procurement
- Personnel
- Property
- Travel

A system is adequate if it is 1) written; 2) consistently followed – it applies in all similar circumstances; and 3) consistently applied – it applies to all sources of funds.

## X. <u>REPORTING REQUIREMENTS</u>

Regular reports by Subrecipient shall include:

a) Programmatic Reports- Subrecipient shall provide quarterly programmatic reports to DEMA within fifteen (15) working days of the last day of the quarter in which services are provided. Subrecipient shall use the form provided by DEMA to submit quarterly programmatic reports. The report shall contain such information as deemed necessary by DEMA. Subrecipient shall use the Quarterly Programmatic Report Format template, a copy of which is attached as Exhibit X(a). If a project has been fully completed and implemented, and there will be no further updates, then the quarterly programmatic report for the quarter in which the project was completed will be sufficient as the final report. The report should be marked as final and should be inclusive of all necessary and pertinent information regarding the project as deemed necessary by DEMA. Quarterly programmatic reports shall be submitted to DEMA until the entire scope of the Grant is completed. Upon request of DEMA, Subrecipient must provide to DEMA information necessary to meet any state or federal reporting requirements.

## b) Quarterly Programmatic reports are due:

#### d) Financial Reimbursements

Subrecipient shall provide DEMA with quarterly requests for reimbursement. Reimbursements shall be submitted with the Reimbursement Form provided by DEMA, a copy of which is attached as Exhibit X(d).

Subrecipient shall submit to DEMA a final reimbursement for expenses received and invoiced prior to the end of the termination of this Agreement no more than **forty-five** (45) calendar days after the end of the Agreement. Requests for reimbursement received by DEMA later than the forty-five (45) days after the Agreement termination will not be paid. The final reimbursement request as submitted shall be marked FINAL.

DEMA requires that all requests for reimbursement are submitted via U.S. mail (United States Postal Service), FedEx, UPS, or another established private delivery service, or in person. Reimbursements submitted via fax or by any electronic means will not be accepted.

DEMA reserves the right to request and/or require any supporting documentation and/or information DEMA believes necessary in order to process reimbursements. Subrecipient shall promptly provide DEMA with all such documents

All reports shall be submitted by Subrecipient to the DEMA contact person as described in Part XXXVII, NOTICES, of this Agreement.

## XI. ASSIGNMENT AND DELEGATION

Subrecipient may not assign any rights hereunder without the express, prior written consent of both parties.

## XII. AMENDMENTS

Any change in this Agreement including but not limited to the Description of Services and budget described herein, whether by modification or supplementation, must be accomplished by a formal Agreement amendment signed and approved by and between the duly authorized representative of Subrecipient and DEMA.

Any such amendment shall specify: 1) an effective date; 2) any increases or decreases in the amount of Subrecipient's compensation if applicable; 3) be titled as an "Amendment," and 4) be signed by the parties identified in the preceding sentence. Subrecipient expressly and explicitly understands and agrees that no other method of communication, including any other document, correspondence, act, or oral communication by or from any person, shall be used or construed as an amendment or modification or supplementation to this Agreement.

## XIII. AGREEMENT RENEWAL

This Agreement shall not bind nor purport to bind DEMA for any contractual commitment in excess of the original Agreement period.

## XIV. RIGHT TO ASSURANCE

If DEMA in good faith has reason to believe that Subrecipient does not intend to, or is unable to perform or continue performing under this Agreement, DEMA may demand in writing that Subrecipient give a written assurance of intent to perform. If Subrecipient fails to provide written assurance within the number of days specified in the demand, DEMA at its option may terminate this Agreement.

## XV. CANCELLATION FOR CONFLICT OF INTEREST

DEMA may, by written notice to Subrecipient, immediately cancel this Agreement without penalty or further obligation pursuant to A.R.S. § 38-511 if any person significantly involved in initiating, negotiating, securing, drafting or creating the Agreement on behalf of the State or its subdivisions (unit of Local Government) is an employee or agent of any other party in any capacity or a consultant to any other party to the Agreement with respect to the subject matter of the Agreement. Such cancellation shall be effective when the parties to the Agreement receive written notice from DEMA, unless the notice specifies a later time.

## XVI. THIRD PARTY ANTITRUST VIOLATIONS

Subrecipient hereby assigns to the State of Arizona any claim for overcharges resulting from antitrust violations to the extent that such violations concern materials or services supplied by third parties to Subrecipient toward fulfillment of this Agreement.

## XVII. <u>AVAILABILITY OF FUNDS</u>

Every payment obligation of DEMA under this Agreement is conditioned upon the availability of funds appropriated or allocated for the payment of such obligations. If the funds are not allocated and available for the continuance of this Agreement, DEMA may terminate this Agreement at the end of the period for which funds are available. No liability shall accrue to DEMA in the event this provision is exercised, and DEMA shall not be obligated or liable for any future payments or for any damages as a result of

termination under this part XVII, including purchases and/or contracts entered into by Subrecipient in the execution of this Agreement.

## XVIII. FORCE MAJEURE

If either party hereto is delayed or prevented from the performance of any act required in this Agreement by reason of acts of God, strikes, lockouts, labor disputes, civil disorder, or other causes without fault and beyond the control of the party obligated, performance of such act will be excused for the period of the delay.

## XIX. PARTIAL INVALIDITY

Any term or provision of this Agreement that is hereafter declared contrary to any current or future law, order, regulation, or rule, or which is otherwise invalid, shall be deemed stricken from this Agreement without impairing the validity of the remainder of this Agreement.

## XX. ARBITRATION

In the event of any dispute arising under this Agreement, written notice of the dispute must be provided to the other party within thirty (30) days of the events giving the rise to the dispute. In the event that the parties cannot resolve their dispute on an agreed-upon basis, either party may invoke arbitration through the American Arbitration Association ("AAA"), with the arbitrator to be selected pursuant to AAA rules and the arbitration to be conducted according to the applicable AAA rules, and with the costs of arbitration (including but not limited to the arbitrator's fees, attorneys' fees, and costs) to be allocated between the parties by the arbitrator. Both parties being sovereign entities, the parties agree that any litigation to enforce an arbitration award or for any other purpose shall be only in the U.S. District Court for the District of Arizona in Phoenix, Arizona as the proper forum for litigation between sovereign entities located in the State of Arizona. In the event that the parties becoming involved in litigation with each other for any reason in any other forum, both parties agree to have any claim(s) against the other resolved in arbitration on the terms set forth in this part XX.

## XXI. GOVERNING LAW AND CONTRACT INTERPRETATION

- a) This Agreement shall be governed and interpreted in accordance with the laws of the State of Arizona.
- b) This Agreement is intended by the parties as a final and complete expression of their agreement. No course of prior dealings between the parties and no usage of the trade shall supplement or explain any terms in this document.
- c) Either party's failure to insist on strict performance of any term or condition of the Agreement shall not be deemed a waiver of that term or condition even if the party accepting or acquiescing in the nonconforming performance knows of the nature of the performance and fails to object.

## XXII. ENTIRE AGREEMENT

This Agreement and its Exhibits constitute the entire Agreement between the parties hereto pertaining to the subject matter hereof and may not be changed or added to except by a writing signed by all parties hereto in conformity with Part XII of this Agreement; provided; however, that DEMA shall have the right to immediately amend

this Agreement so that it complies with any new legislation, laws, ordinances, or rules affecting this Agreement. Subrecipient agrees to comply with any such amendment within ten (10) business days of receipt of a fully executed amendment. All prior and contemporaneous agreements, representations, and understandings of the parties, oral, written, pertaining to the subject matter hereof, are hereby superseded or merged herein.

## XXIII. RESTRICTIONS ON LOBBYING

Subrecipient shall not use funds made available to it under this Agreement to pay for, influence, or seek to influence any officer or employee of a State or Federal government.

## XXIV. LICENSING

Subrecipient, unless otherwise exempted by law, shall obtain and maintain all licenses, permits, and authority necessary to perform those acts it is obligated to perform under this Agreement.

## XXV. NON-DISCRIMINATION

Subrecipient shall comply with all State and Federal equal opportunity and non-discrimination requirements and conditions of employment, including the Americans with Disabilities Act, in accordance with A.R.S. title 41, Chapter 9, Article 4 and Executive Order 2009-09.

## XXVI. SECTARIAN REQUESTS

Funds disbursed pursuant to this Agreement may not be expended for any sectarian purpose or activity, including sectarian worship or instruction in violation of the United States or Arizona Constitutions.

## XXVII. ADVERTISING AND PROMOTION OF AGREEMENT

Subrecipient shall not advertise or publish information for commercial benefit concerning this Agreement without the written approval of DEMA.

## XXVIII. CLOSED-CAPTIONING OF PUBLIC SERVICE ANNOUNCEMENTS

Any television public service announcement that is produced or funded in whole or in part by Subrecipient shall include closed captioning of the verbal content of such announcement.

## XXIX. INDEMNIFICATION

To the extent permitted by law, each party (as indemnitor) agrees to indemnify, defend and hold harmless the other party (as indemnitee) from and against any and all claims, losses, liability, costs, or expenses (including reasonable attorney's fees) (hereinafter collectively referred to as claims) arising out of bodily injury of any person (including death) or property damage, but only to the extent that such claims which result in vicarious/derivative liability to the indemnitee, and are caused by the act, omission, negligence, misconduct, or other fault of the indemnitor, its officers, officials, agents, employees, or volunteers.

## XXX. <u>TERMINATION</u>

a) All parties reserve the right to terminate the Agreement in whole or in part due to the failure of Subrecipient or DEMA to comply with any term or condition of the

Agreement, to acquire and maintain all required insurance policies, bonds, licenses and permits or to make satisfactory progress in performing the Agreement. The party wishing to terminate this Agreement shall provide the other party with a written thirty (30) day advance notice of the termination and the reasons for it.

- b) If Subrecipient chooses to terminate this Agreement before the grant deliverables have been met then DEMA reserves the right to collect from Subrecipient all funds distributed by DEMA under this Agreement to Subrecipient.
- c) DEMA may, upon termination of this Agreement, procure, on terms and in the manner that it deems appropriate, materials or services to replace those under this Agreement. Subrecipient shall be liable to DEMA for any excess costs incurred by DEMA in procuring materials or services in substitution for those due from Subrecipient.

#### XXXI. CONTINUATION OF PERFORMANCE THROUGH TERMINATION

Subrecipient shall continue to perform, in accordance with the requirements of the Agreement, up to the date of termination, as directed in the termination notice.

## XXXII. COUNTERPARTS

This Agreement may be executed in any number of counterparts, copies, or duplicate originals. Each such counterpart, copy, or duplicate original shall be deemed an original, and collectively they shall constitute one agreement.

## XXXIII. AUTHORITY TO EXECUTE THIS AGREEMENT

Each individual executing this Agreement on behalf of Subrecipient represents and warrants that he or she is duly authorized to execute this Agreement.

## XXXIV. SPECIAL CONDITIONS

The Apache County Emergency Management is under the Apache County Sheriff's Office. There are three full time employees who manage the EM. The EM Director, who is also the Chief Deputy, is responsible for overseeing the

program. This is accomplished by his time being divided at 50% to EM and the remainder to the ACSO. The Director sets goals, serves as the policy leader, and provides guidance for the program. He also establishes priorities, and coordinates response support during events/disasters. The EM Coordinator is responsible for reviewing, developing and maintaining plans, coordinating response support and operations of the EOC with the Director, His time is divided into 80% for EM and the remainder to the ACSO. The EM Specialist is funded at 100% to EM. She is responsible for day to day operations, maintaining the EMPG grant, compiling the programmatic reports, financial reimbursements, and coordinates with the EM Coordinator and Director with operations of the EOC. All hours worked by the EM staff are submitted weekly through the county's electronic reporting system, along with paper time sheets submitted to the Sheriff's Office. The EM program is funded through the EMPG award and is matched by a \$40,000 County general fund contribution, and the remainder of the funds is matched by the Sheriff's Office funding through salary and cost match for EM expenditures. In kind salaries will be used for those employees who are not federally funded but assist emergency management in various functions such as ham radio/state radio meetings, EM equipment maintenance, search & rescue. In kind volunteer will be used for the AVERT/CERT, community volunteer group, LEPC the Sheriff's Posse, and the call center volunteers. In kind labor will be for county personnel that are called in to assist during events or training & exercises. In kind equipment funds will be used for various equipment used during events, training, exercises and that was not purchased by EM funds.

This year we are adding the weather alert to the mass notification system to enhance the public information and warning. Under the THIRA, one of the identified threats to our County is Wildland Fires, and severe winter storms. Having a weather alert system will help keep the public notified to ensure they are fully prepared for an impending threat. The Copiers yearly maintenance ensures the copier is running to its full capacity and if any area of trouble occurs, it is covered by the maintenance agreement. Administrative cost and software from BOLD Planning is to update the Apache County Emergency Operations Plan. We will be seeking non-federal contribution from Apache County General Fund along with the Apache County Health Departments tax based funds.

Items listed under other covers cell phone use/upgrades, landline telephone usage, propane that is charged to the EOC, where staff has offices located to conduct day to day business. Fuel and vehicle maintenance cost is used for only the EM vehicles. These vehicles are used by EM staff to travel to work, meetings, training and can also be used as an onsite EOC if need be. Also included are items that would enhance the EM productivity. Pelican cases will be used as "go bags" for the EM staff and used to store laptops and radios. The propane heaters and the portable remote lighting systems will be utilized during events/disasters. The remote lighting is battery operated giving flexibility to take in the field for night operations along with the portable heaters, which offer the ability to transport heat easily during events that mandate outside operations. Computers, laptops, printers, and scanners will be used to replace items that have met their shelf life expectancy. The binoculars will be utilized by EM staff who also serves as Search and Rescue Coordinator as a tool for S&R activities. The storage unit will be a steel 40 foot storage unit. This will be used to house all EM equipment and files in storage. The storage unit will be accessible to EM staff and will be enclosed within the fenced area. This ensures extra security, and with the unit being steel, it ensures safety from water, fire, and other forms of erosion.

## **RECITALS**

WHEREAS, Lessec desires to lease space from Lessor for use as a Sub-Station for the Apache County Sheriff's Office; and

WHEREAS, Lessor is willing to provide space for such purpose in the terms and conditions hereinafter set forth; and

WHEREAS, Lessor is authorized to enter this Agreement pursuant to A.R.S § 15-342(9)

**THEREFORE**, in consideration of the premises and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties hereto agree as follows:

## **AGREEMENT**

- 1. <u>Premises.</u> Lessor hereby leases to Lessee Rooms Forty (40), and Forty-two (42) of the Yellow Building (Leased Premises) for use as a Sub-Station by the Apache County Sheriff's Office.
- 2. <u>Term.</u> This lease will remain in force for a period of one year, commencing on the 1st day of July, 2016 and ending on the 30th day of June, 2017.
- 3. Renewal. Renewals of this Lease shall not be automatic. Ninety (90) days prior to expiration of current Lease term, Lessee may request an extension of this Lease for a period of one (1) year commencing on the day the current term expires and ending one year from that date. Such renewal reqests must be made in writing, addressed to the individual contact designated in this Lease or otherwise designated in writing and acknowledged by both parties. The Governing Board must approve all Lease extensions.
- 4. <u>Termination</u>. Either party to this Lease may terminate this Lease by giving the other party ninety (90) days written notice addressed to the individual or contact designated in the Lease or otherwise designated in writing and acknowledged by both parties. Lessor may

automatically terminate this Lease upon thirty (30) days' notice to Lessee for Lessee's nonpayment of rent. The parties hereby acknowledge and agree to the applicability of A.R.S. § 38-511.

- 5. <u>Rent.</u> Rent in the amount of three hundred and twenty-five dollars (\$325.00) per month shall be paid by Lessee to Lessor in advance on the first day of each month, which covers all Lessee space here in described. Lessor may adjust the rent at the beginning if any renewal of the Lease.
- 6. <u>Utility Expenses</u>. During the term of this Lease or any renewal, Lessee shall be responsible for paying electric and propane utility expenses associated with the Leased Premises. Lessor shall make arrangements with local propane and electric utility companies to create seperate utility accounts in the name of the Lessees to cover the Leased Premises. Lessee shall be responsible for maintaining these accounts with the utility providers. Lessee shall be responsible for a \$25 flat fee a month for water and waste water management. This fee will be included in the monthly rent.
- 7. <u>Maintenance</u>. For the length of the Lease Term, all maintenance shall be provided by the Lessec including painting electrical fixtures, (including replacement of light bulbs and ballasts) locks, windows, heating and cooling equipment, etc. within the Leased Premises. In the event that Lessee is issued keys by Lessor which are lost, all costs to rekey the Leased Premises, and any other locks of Lessor accessed or had access to via the lost key shall be borne by Lessee.
- **8.** Remodeling. Lessee is solely responsible for all remodeling costs associated with its use of the Leased Premises.
- 9. Insurance and Indemnity. Lessee shall at all times during the Term or renewal of this Lease maintain policies of insurance consisting of general liability, worker's compensation and employee's liability and property coverage in an amount consistent with industry standards. All such insurance shall, if available, name Lessor, its Governing Board members, officers, employees and agents as additional insured, and shall be primary to any other available insurance. Lessee shall indemnify and save Lessor harmless from and against any and all claims, demands, actions, damages, liability and expense (including attorney fees and costs) in connection with loss of life, personal injury, and/or property damage arising form or out of any occurrence in, upon, or at the premises leased hereunder, or from Lessee's occupancy thereof.
- 10. Assignment and Subletting. Lessee may not assign this Lease or sublet the Lease Premises.
- 11. <u>Notices.</u> Any notice required hereunder shall be in writing and given by mailing the same by United States Mail, registered or certified, return receipt requested, addressed as
