OFFICIAL PROCEEDINGS OF THE APACHE COUNTY BOARD OF SUPERVISORS MEETING

September 4, 2019 St. Johns, Arizona

Present were: Chairman Joe Shirley, Jr. Vice Chairman Travis Simshauser and Supervisors Alton Shepherd. Also present were County Manager/Clerk of the Board Ryan Patterson, County Attorney Michael Whiting and Chief Deputy Attorney Joe Young.

Chairman Shirley called to order the Board of Supervisors meeting at 8:30 a.m. in the Board of Supervisors chambers, County Annex Building, 75 West Cleveland Street, St. Johns, Arizona, and welcomed all in attendance.

SueAn Stradling-Collins gave the invocation.

Timothy Hinton led the Pledge of Allegiance.

Chairman Shirley called for the Public Health Services District items.

Preston Raban, Health Director, presented the Clinical Services Quarterly Update for April – June 2019. No action was needed or taken,

Preston Raban, Health Director, requested approval of IGA #ADHS 16-097960 Healthy People Healthy Communities Amendment #5 that revises the Scope of Work, Exhibit C and Price Sheet. These changes will not affect the Health Districts scope of work currently in place or the FY20 budget. **Mr. Shepherd moved approval, seconded by Mr. Simshauser**. Vote was unanimous.

Emergency Management: Discussion and possible approval to update the job descriptions for the Emergency Management Department. Vote was unanimous.

Angela Romero, Election Director, requested based on the recommendation of the Republican Party County Chairman, Delos Bond, determine vacancies exist in the office of precinct committeeman and appoint Lynda R. Tanner to the Vernon Precinct. **Mr. Shepherd moved approval, seconded by Mr. Simshauser**. Vote was unanimous.

Angela Romeo, Election Director, requested approval to cancel the special district election for the Concho Wastewater Improvement District. Mrs. Romero stated this action is due to not receiving any candidate filings and recommended approval. Mr. Simshauser moved approval, seconded by Mr. Shepherd. Vote was unanimous.

Angela Romero, Election Director, requested approval based on the recommendation of the Democratic Party County Chairman, Steven C. Begay, determine vacancies exist in the office of precinct committeeman and appoint Larry Westbrook for the Ft. Defiance Precinct; Patricia Reed, Joanne Peshlakai and Agnes Reed for the St. Michaels Precinct; Caralee Cubbage for the Springerville Precinct; Virginia Dotson for the Vernon Precinct; Allan S. Begay for the Wheatfields Precinct. **Mr. Shepherd moved approval, seconded by Mr. Simshauser.** Vote was unanimous.

Chief Brannon Eagar, on behalf of the Sheriff's Office, requested approval to accept medical kits donated by Alpine Fire Department for use in Sheriff's Office District I vehicles. Mr. Simshauser moved approval, seconded by Mr. Shepherd. Vote was unanimous.

Chief Brannon Eagar, on behalf of the Sheriff's Office, requested approval to accept a grant for the United States Forest Service in the amount of \$11,553.75 with no match required. Chief Eagar stated these funds are used to pay Apache County Sheriff's Deputies overtime to patrol the Apache-Sitgreaves National Forest to provide additional patrol at a minimal cost to the county during weekends and busy holidays. Mr. Simshauser moved approval, seconded by Mr. Shepherd. Vote was unanimous.

Ferrin Crosby, County Engineer, requested approval of the Contract Addendum and Change Order between Apache County and Creative Multimedia, Inc. doing business as CMI Engineering and the amendment will result in a contract increase of \$81,000. Mr. Shepherd moved approval, seconded by Mr. Simshauser. Vote was unanimous.

Ferrin Crosby, County Engineer, requested approval to enter into a Professional Services Contract with Cannon Consultants, LLC, to design a bridge deck for County Road 1009 in Greer. Mr. Crosby stated the cost of the design is estimated at \$20,400 and will be paid using District III HURF funds. Mr. Simshauser moved approval, seconded by Mr. Shepherd. Vote was unanimous.

Ferrin Crosby, County Engineer, requested approval of a 7-year lease/purchase for one 950M Wheel Loader for the limestone pit at a cost of \$34,695 from Empire Machinery, using National Intergovernmental Purchasing Agreement (NIPA) – City of Tucson Contract. **Mr. Shepherd moved approval, seconded by Mr. Simshauser.** Vote was unanimous.

Kerry Pena, on behalf of Emergency Management, requested approval of a Memorandum of Agreement (MOA) between Apache County Emergency Management & Preparedness and the Federal Emergency Management Agency for the Integrated Public Alert & Warning System (IPAWS) —Open Platform for Emergency Networks (OPEN) regarding the use of Apache County Emergency Management & Preparedness Interoperable Systems(s) and IPAWS OPEN. Mr. Shepherd moved approval, seconded by Mr. Simshauser. Vote was unanimous.

Michael Whiting, County Attorney, requested following a possible executive session for legal advice pursuant to A.R.S. §38-431.03(3), discussion and possible approval of a Settlement Agreement with the Navajo Nation to provide additional voting outreach in Apache County and resulting in dismissal of CV2018-08329. Mr. Whiting stated the Navajo Nation filed a lawsuit against Apache, Navajo and Coconino Counties and the issues have been resolved and did not believe an executive session was needed. Mr. Simshauser moved approval, seconded by Mr. Shepherd. Vote was unanimous.

Mr. Patterson presented notification of the following meetings where two or more members of the Apache County Board of Supervisors may be in attendance. No action was needed or taken,

Chairman Shirley opened the floor for call to the public.

Billie Bell, a resident of Apache County stated she is running for the office of School Superintendent and introduced herself to the Board.

Lydia Hill, Transportation Supervisor for Sanders School District requested the County grade and maintain the roads, so the school vehicles don't get damaged driving on the roads.

Fred Footracer, a representative from Houck Chapter and requested assistance with putting in a road for a new cemetery in Sanders, Arizona.

James Watchman, Jr., Houck Chapter Vice President, requested assistance with the maintenance of roads within the Sanders School District. Mr. Watchman stated there is confusion as to which district maintains certain bus routes and would like clarification. Mr. Watchman requested the roads near the Houck Chapter be placed under District III instead of District II since the District III Road Yard is closer to the area. Mr. Watchman requested the roads be graded and dust suppressant applied on the roads.

Art Modica stated he would like the county to have a representative on the Lower Colorado Water Shed. Mr. Modica stated there is confusion as to who is representing Apache County in the litigation and he would like to get some answers.

Chairman Shirley referred all concerns brought up in the call to the public to County Manager Patterson.

Mr. Simshauser moved to adjourn, seconded by Mr. Shepherd. Vote was unanimous.
