- Sheriff's Office: Request approval of Agreement SAP-15-003 between Arizona Criminal Justice Commission and the Apache County's Sheriff's Office for the Substance Prevention and Education grant agreement in the amount of \$11,600. UNANIMOUS APPROVAL

**Engineering Department: E.** Request approval to utilize Navajo County Contract #B15-03-003 for the purchase of asphalt emulsions. **F. Engineering Department:** Discussion and possible approval to add White Mountain Rock Products to yearly bid #201507. Vote was unanimous approval for all consent items.

Chief Deputy Brannan Eagar, on behalf of the Sheriff's Office requested approval to enter into a Sub-grantee Agreement EWWW-2014-EP-00016. The purpose of the Agreement is to specify the responsibilities and procedures for Apache County's role in administering Emergency Management Performance Grant (EMPG) funds. Chief Eagar stated all 15 counties received the same Subgrantee Agreement and just reiterates what is in the main grant and is just needed because the State was audited by the federal government and it was noticed there was not a Sub-grantee Agreement on file. Mr. Weller and Chief Eagar held a discussion regarding the Matching funds required. Mr. Weller moved approval, seconded by Mr. White. Vote was unanimous.

Mr. Wengert presented the request for approval of Liquor License Transfer Application #P1073552 for Pete Phillips, the Screamin' Chicken Bar & Grill, Hwy 61, Concho, Arizona. Mr. Wengert stated no protests or opposition was received. Mr. White moved approval, seconded by Mr. Weller. Vote was unanimous.

There was no member of the public wanting to address the Board during call to the public.

Mr. White moved to adjourn the meeting, seconded by Mr. Weller. Vote was unanimous.
