		<b><u>REQUIRED DOCUMENTS:</u></b> (If new to ECSD only) I understand that I will need to submit birth certificate, immunization record, proof of Nevada residency, 6-8 copy of last report card, 9-12 official transcript, and signed release of records. A close-up picture will need to be emailed directly to NNVA.
		I understand that my child's immunization record will be reviewed by a school nurse and missing immunizations may delay enrollment.
		I understand I will be required to complete, and return a " <u>Plan of Study</u> ", signed by both parent/guardian and student to NNVA prior to enrollment being approved.
		I understand the " <u>Plan of Study</u> " is used to schedule both semesters. <u>Failed courses</u> will be made up in the next academic year or during summer school.
		I understand that if I indicated my child has " <u>Special Needs</u> " a current IEP or 504 will need to be submitted.

		<b><u>COMMUNICATION WITH EDGENUITY TEACHERS</u></b>
		I understand that my child will login and send a message to the teacher of each course, introduce themselves and tell the teachers a little about them.
		I understand that my child will need to correspond with the teachers in each of his or her courses at least once a week.
		I understand that my child will complete course work at a pace that will allow him or her to finish courses within the allowable time period.
		I understand that my child will need to contact his or her online teachers if he or she needs help with course work.

	<p><b><u>COURSE REQUIREMENTS:</u></b>  I understand that my child will need to complete at least 6-courses each semester. Additional courses will be required if graduation requirements cannot be met through the completion of 6 courses each semester. Seniors are exempt from this requirement if requirements have been met in previous years.</p>

	<p><b><u>TESTING:</u></b>  I understand that my child enrolled in NNVA will need to participate in state-mandated testing at their designated area (requires transportation) SBAC / ACT / Math/English/Science “End of Course”.</p>

	<p>I understand that my child may need to participate in MAPs testing throughout the year. These tests are to be conducted at home. Parents may only assist in logging their child into the test, not any part of the test itself. This helps with the validity of the results.</p>

	<p><b><u>PROBATION/PROGRAM UNENROLLMENT</u></b>  I understand that without adequate progress (60% or higher) my child will be placed on academic probation. Academic contract will provide a time line for improvement or unenrollment from NNVA.</p>

	<p><b><u>ABSENCES</u></b>  Per Nevada Statute 392.130, I understand that if my child has unexcused absences of 15 - school days or more, they will be unenrolled and notice will be sent to their zone school office.</p> <p>I understand I will receive a notice of potential unenrollment from NNVA per email when there has been 5-days and 10-days absence.</p>

	<p><b><u>PARENTS/GUARDIANS</u></b>  I understand that I will monitor my child’s progress at least once a week, make sure my child is logging into their courses 5-days each week, communicating with their teachers and complete assignments each week. My child will work at a pace that will ensure he or she is completing all courses within the allowable time limits.</p>
